HOW WILL THE PLAN BE ORGANIZED AND IMPLEMENTED:

PHASE I: "Organizational Meeting" – This phase of the project focuses on the organization of a group of interested church members and skilled volunteers into project subcommittees (i.e. Public Relations, Medical, Logistics, Resources, Culinary Services, Counseling, Finance, Personal Hygiene and Clothing Distribution).

PHASE II: "Official Contact With the City of Riverside, CA" - This phase charges the Public Relations subcommittee with the scheduling of an official meeting with the Coordinator of Homeless Solutions of the City of Riverside. The purpose of the meeting will be to inform the City of Riverside of the intent of Healing Hearts Ministries to offer specific humanitarian services to the homeless population of Ward 7 of the Riverside City District. Moreover, guidance and direction regarding city regulations and policies, referent to assisting the homeless population, will be sought. Special permits will also be procured where necessary.

PHASE III: "Ministry of Presence and Initial Outreach" – In an attempt to get aquainted with the target population and assess its needs, seven organized groups of 4-6 church members will go out into the designated areas to meet and greet the homeless, providing them with a Ziploc bag containing fruits, granola bars, a bottle of water, and a pair of socks. The groups will assess the most urgent needs of the homeless they encounter. The groups will pray with those homeless who accept the offer for prayer. This activity will go on for about 6-7 weeks as the groups get to know the homeless and gain their trust.

PHASE IV: "Launch of Humanitarian Services" – The following humanitarian services will be offered at the church location two times each month: a hot meal, a haircut, basic medical consultation/attention, a change of clothing, use of the showers at the church's facility, a special "Worship of Spiritual Rest and Hope" geared toward the attendees served. Healing Hearts Ministries of LSSC, with the approval of the City of Riverside, will work to supply the needs of the prescribed homeless population that will be served. Moreover, referrals will be made to appropriate agencies that are equipped to give assistance beyond the scope of what Healing Hearts Ministries can adequately provide.

EXPECTED RESULTS:

PHASE I:

All subcommittees are already formed and are presently functioning as of January 12, 2019.

PHASE II:

The City of Riverside, through the Office of the Coordinator of Homeless Solutions, visited and assessed the facilities of LSSC and subsequently approved the site for the proposed project. All required official permits for the project are in place.

PHASE III:

The following have already been initiated and is ongoing as of January 12, 2019: Initial contact with the designated homeless population; distribution of food packages; success in establishing mutual trust and goodwill with the homeless visited so far; prayer with most of the homeless contacted.

PHASE IV:

Expected results include, but are not limited to: 1) Positive physical transformative change in the lives of the homeless served, as evidenced by their physical appearance after receiving assistance; 2) Emotional and mental healing, as evidenced by the attitudes and demeanor of those served; 3) Recovery from common minor illnesses, as per the evaluation and assessment of the Healing Hearts Ministries medical team; 4) Spiritual awareness and searching for God (by those served), as evidenced by the interest in spiritual things and a yearning to hear and obey the Word of God; 5) Restored normalization of the lives of some of the homeless served, as evidenced by those who manage to get off the streets and function again in society because of the hope that the assistance sparked in their being; 6) Spiritual transformation of the church members who volunteer, as evidenced in their increased desire, through this project, to be the hands and feet of God to a needy and hurting world; 7) The establishment of a mutually satisfactory relationship with the City of Riverside, as evidenced by a successful partnership in helping the community; 8) The extension of targeted pastoral care to the homeless population served.
